Grand Queen Contest The Official Rules and Regulations for 2018

- Participant must be a female member of the Eastern Star of Hawaii, and a member in good standing.
- No entry fee for the Grand Queen Competition, the contestant who raises the highest amount of funds will be crowned Grand Queen.
- Application is due to the Grand Chapter 30 September 2017 and a brief resume and picture must be submitted to the Grand Chapter on or before May 1, 2017.
- Contestants must wear white formal regalia and a small tiara for coronations. Each Subordinate Chapter should supply the tiara for their contestant.
- The Queen Contestants and their Worthy Matron or Chapter Representative must turn over all monies to the Grand Secretary and Grand Queen Committee members on the 1st day of conference (Friday) no later than 8:00 AM. All cashier checks or money orders must be made to Prince Hall Grand Chapter of Hawaii. NO personal checks will be accepted; NO exceptions. The Grand Secretary and the Grand Queen Committee members must adhere to the strictest confidentially when collecting funds.
- All contestants will conduct themselves with integrity and honesty. Any misconduct of a contestant and an O.E.S. member as it pertains to our governing laws will not be tolerated and its perception as well the negative impact it carries will not be allowed to undermine the integrity of the Grand Queen Contest nor the Grand Chapter. If there are circumstances that arise from inappropriate conduct, the Grand Chapter may take further action per Chapter III, Article I, Section 1. and Article II, Section 1 of the Prince Hall Grand Chapter of Hawaii Constitution and Bylaws.
- All advertisements using the Grand Chapter's name MUST be approved by the Grand Chapter.
- Recommend the Grand Queen Contestants share their Fundraising calendars with each other to help prevent any scheduling
 conflicts. Fundraising events should not rely solely on the fraternal organization but include the community as well.
- The crown, robe and sash will be presented to the Grand Queen for the ensuing year. She will be crowned for one year and return the following year at Grand Communication to assist in crowning the new Grand Queen.
- The Newly crowned Grand Queen, MUST sign a PHGC Form 104 (0615), form included in this packet for all Grand Queen paraphernalia given to her for her term as OES Grand Queen. As well as the 1st and 2nd Runner up.
- The final report for the Grand Queen contest must be made at Grand Communication by the Grand Queen Counsel.





Grand Queen Duties & Responsibilities

- 1. Grand Queen is required to attend all Grand Chapter events if she is NOT able to attend then the 1st Runner Up and or 2nd Runner Up attends to represent the Grand Queen position, such as:
- 2. Grand Official Visit's (September, October, April, May)
- 3. Grand Chapter Training (August, October, December, February, April, June)
- 4. Martin Luther King Parade (January)
- 5. Grand Communication Conference (June)
- 6. The Grand Queen would do one Community Service Project of her choice. She can ask for assistance from any member of the jurisdiction to assist her with her efforts.
- 7. The Grand Queen Counsel will host a fundraiser for all Grand Queen Contestants from each chapter. Each contestant can have a table to sell their items of their choice. Example: (i.e., the pancake breakfast or the Brunch, Tea party etc.). Then all proceeds will be divided among the three chapters that the contestant represents; equally.

The Grand Queen will also receive a Past Grand Queen Crown at the next Grand Communication.

If no Contestant raises \$2000.00 or more the contestant who raises the highest amount of funds over \$1500.00 will be crowned as the Grand Chapter Queen and will receive, hotel accommodations the following year for one night (the day of the banquet), free admission to Grand communication and the Banquet the following year and a convertible car to ride in as Grand Queen in the Martin Luther King Jr. parade the following year. The current year she will receive a Grand Chapter trophy, a sash, a robe, recognition at the Grand Communication banquet, an invitation by the Grand Worthy Matron to join her at all Grand Visitations as the Grand Queen, and will sit in front of the Dais during Grand Communication after being crowned. The Grand Queen will also receive a Past Grand Queen Crown at the next Grand Communication.

If no Contestant raises \$1500.00 or more the contestant who raises the highest amount of funds over \$1000.00 will be crowned as the Grand Chapter Queen and will receive free admission to Grand Communication and the Banquet the following year and a convertible car to ride in as Grand Queen in the Martin Luther King Jr. parade the following year. The current year she will receive, a Grand Chapter trophy, a sash, a robe, recognition at the Grand Communication banquet, an invitation by the Grand Worthy Matron to join her at all Grand Visitations as the Grand Queen, and will sit in front of the Dais during Grand Communication after being crowned. - 5. The first and second runner-ups will each receive a sash, a Grand Chapter trophy, and recognition will be given to them in all OES functions throughout the Jurisdiction should she be present.
- 6. Each Contestant will receive 10% of funds raised within 60 days after Grand Communication.
- 7. The Chapter of the winning Contestant will receive 5% of funds raised by the winning Contestant within 60 days after Grand Communication.
- 8. All regalia of the Grand Queen, the 1st and 2nd runners up must be returned the following year to the Grand Chapter Queen Department at Grand Communication.
- 9. If the Grand Queen is not able to attend Grand Communication, the banquet, or the parade the following year she will be represented by the 1st runner-up, if she is not able to attend then the 2nd runner up will represent the Grand Queen.
